The Spa Industries Global Extended Equipment Warranty provides additional warranty coverage on your spa for a period of up to 5 years from the original date of purchase. The Spa Industries Global Extended Equipment Warranty covers the spa controller, touchpads, auxiliary touchpad, all lets, diverter valves, air controls, eco-filtration pumps, massage pumps, heater element, blower, ozone unit, control valves and any leaks found to be caused by these parts. The Spa Industries Global Extended Equipment Warranty covers all equipment mounted underneath the spa shell associated with the water circulation and maintenance system

In some cases you may need an authorised Spa Industries Global Service Technician to attend to diagnose and determine the fault as well as remove and reinstall any faulty item. Any repair performed by an unauthorised Service Technician will void the Spa Industries Global Extended Equipment Warranty. The extended warranty does not apply to any items excluded from the scope of the initial warranty and applies to equipment only, not labour charges.

The Spa Industries Global Extended Equipment Warranty is for a period of 5 years from the original date of purchase and takes effect on the expiry of the initial equipment warranty. This warranty covers parts for loss of functionality only and not appearance.

Peace of mind

The Spa Industries Global Extended Equipment Warranty gives you the benefit of additional warranty protection after the conclusion of the initial standard Warranty.

Subject to the Exclusions, Spa Industries Global Extended Warranty provides you with peace of mind for any listed part failure associated with the water circulation and maintenance system of your spa.

Should an issue arise with your spa within the Spa Industries Global Extended Equipment Warranty period, please contact our customer service department and we will repair or replace the part required in accordance with the Spa Industries Global Extended Equipment Warranty.

Claim Process

Any part which is easily replaced by the customer and deemed to be faulty under this Warranty, must be returned to Spa Industries at the customers expense for testing. If Spa Industries Global find the part to be faulty, a replacement part will be sent free of charge back to the customers nominated address. Replacement parts requiring a Service Technician to install will be sent directly to the allocated Service Technician.

Warranty will be deemed to be void if any of the following occur:

- The spa has been subject to alteration, neglect, misuse or abuse.
- · Any repairs attempted by anyone other than an authorised agent of Spa Industries Global.
- The spa has been used in a non-residential application or in an application for which it was not designed.
- Damage is caused by an Act of God or any other cause beyond the control of Spa Industries Global.
- · Damage is caused by the addition or use of any non-approved mechanical or electrical component or chemical substance.
- Damage is caused by shipping, moving, mishandling, improper installation or electrical hook-up by someone other than a licensed Electrician.
- . Damage to the spa shell is caused by excessive heat build-up due to failure to cover the spa when empty of water and/or exposed to direct sunlight.
- Damage is caused by operating the spa outside the water temperature range of (0°C-40°C).
- · Damage is caused by improper maintenance of spa water chemistry.
- Damage is caused by failure to install, maintain and operate the spa in accordance with the recommendations contained in the Spa Industries Global Owner's Manual,
- Pre-Delivery Guide or any other printed instructions, notice or bulletin from Spa Industries Gloabl. • The spa has been fitted with non genuine Spa Industries Global filters. If non genuine Spa Industries Global filters are used this could cause damage to the filtration, heating and control system of the spa and will void the warranty of these components.
- If you are a member and have had your Home Chemical Care Plan deferred, cancelled or terminated.
